# Our Most Impactful Year Yet

Your investments powered the expansion of our programs to meet the growing need during our fiscal year from July 2022 to June 2023.



**2,998**

Students received Breaktime-Mealtime™ food support during school breaks to prevent hunger and provide nourishment.

**Our Breaktime-Mealtime™ program** provides Safeway grocery store food vouchers to replace school meals when schools are on breaks and for emergency food security needs throughout the year.



**576**

Children from **300** families received emergency rent assistance to provide stability and prevent homelessness.

**Our Emergency Assistance program** supports families with rent assistance, first month's rent payment, and financial aid to prevent eviction during their time of need.

## The Impact of Grocery Store Food Vouchers

### Personal Choice

Families are able to have a personalized experience where they can shop for food that aligns with their dietary preferences and cultural considerations.

### Dignity and Autonomy

Individuals and families are empowered to make their own food choices, preserving their dignity and autonomy.

### Reduced Stigma

Individuals may feel stigmatized when seeking assistance from a food bank. Vouchers can be a discreet way to obtain help without drawing attention to one's economic situation.

### Variety and Freshness

Families are able to access a wider variety of fresh, nutritious foods, including fruits, vegetables, and perishable items, which may not always be readily available at food banks.

### Accessibility

Safeway grocery stores are often located in areas that are more accessible to a broader range of families, making vouchers a more convenient option for many of the families we support.

Students received new back-to-school clothing so they feel confident and self-assured.

**Our Clothes-4-Kids™ program** provides students with the opportunity to select new school clothing from Amazon and local merchants.

Families received holiday food and gift support from generous donors, making their holiday season happy, healthy, and bright!

**Our Holiday Giving program** provides holiday gift and food support for children and families in need.

## The Bellevue Family Hub Opens and Provides Immediate Impact



In August 2022, we opened our first Bellevue Family Hub in partnership with the Bellevue School District. The Hub is a resource center where families can visit and receive in-person support from a Bellevue LifeSpring team member.

In just the first two weeks of operation, we assisted more than **297 families** with **499 children**. We provided new back-to-school clothing to **515 students**, food support to **135 students**, and assisted **110 students** with signing up for the Free-and-Reduced-Price Meal Program so that they could receive food assistance.

## Uncork the Night Returns!



After a three-year pandemic postponement, we hosted Uncork the Night in October of 2022. Bellevue community members, business leaders, and philanthropists joined us to wine, dine, and raise their paddle in support of Bellevue kids. Thanks to an outpouring of generosity, we raised \$374,959 to help prevent Bellevue children from experiencing hunger and homelessness.

We hosted our 22nd Annual Step Up to the Plate Benefit Luncheon in April 2023. Our community stepped up and collectively raised \$530,182 to foster stability and self-sufficiency for Bellevue children and their families. We honored Amazon with our annual Wings Award. We honored Fairweather Circle Member Joan Valaas with the 2023 Trish Carpenter Volunteer of the Year award, and Life Member Jean Haehl with a special Lifetime Achievement award.

# A Year of Community



In July 2022, the Bellevue LifeSpring Youth Council hosted more than 130 community members at their annual 5k Fun Run to raise awareness and funds to fight hunger for Bellevue kids. The event was a big success, raising a total of \$7,000!

In August 2022, Amazon employees assembled and delivered more than 2,500 snack packs for Bellevue students. It's hard to focus on an empty stomach. Thanks to Amazon's support, all Bellevue School District schools were stocked and ready with snacks for when students needed a boost.

In August 2022, we opened our first Bellevue Family Hub at Highland Middle School. Volunteers helped us move in and set up the space. Thanks to their hard work, we created a warm and welcoming space for families to visit and receive in-person support.

In December 2022, we were grateful for the opportunity to share our appreciation for the Bellevue Collection, Kemper Development Company, and the Kemper Freeman Family for the invaluable leadership and partnership they provided Bellevue Lifespring over the last century. Thanks to their gift of guaranteeing Thrift Culture, Bellevue LifeSpring's former thrift shop, rent of only \$1 per year, we were able to use profits from the store to directly support Bellevue kids.

In February 2023, Bellevue LifeSpring's One Circle raised an incredible \$176,105 at their One Heart/One Community gala. The energy of the night was contagious, with over 150 guests raising their paddles to support Bellevue children. Funds raised immediately went toward providing food support for Bellevue children.

In April 2023, the Bellevue LifeSpring Fairweather Circle hosted a "Pop-Up, It's Spring" sale. Circle members carefully curated and hosted a sale of new and gently used clothing, accessories, home goods, and more — all with the purpose of raising funds to help provide food and housing support to local children and their families. They did just that and raised more than \$10,000 for Bellevue kids!

In April 2023, a dedicated team of T-Mobile volunteers joined us at the Bellevue Family Hub and assembled more than 100 hygiene kits for unaccompanied high school students who often arrive in our community without personal supplies. T-Mobile volunteers also helped prepare food vouchers for distribution to students. All this support was in addition to an incredible investment of \$20,000 from the T-Mobile Foundation.

In May 2023, we launched our first Bellevue LifeSpring Listening Circle with our friends at Africans on the Eastside. Developed by the Bellevue LifeSpring Diversity, Equity, and Inclusion Committee, our Listening Circles are safe and inclusive spaces where Bellevue families are invited to share their experiences, perspectives, and thoughts on Bellevue LifeSpring programs and services.

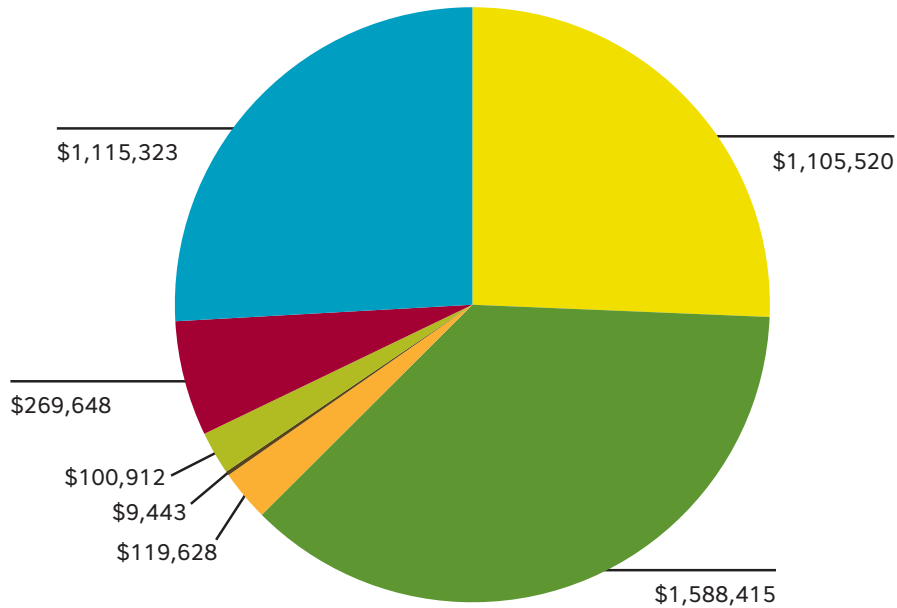

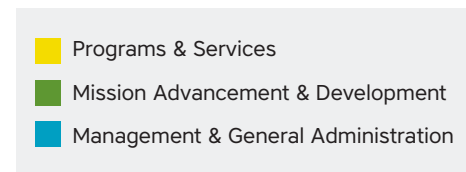
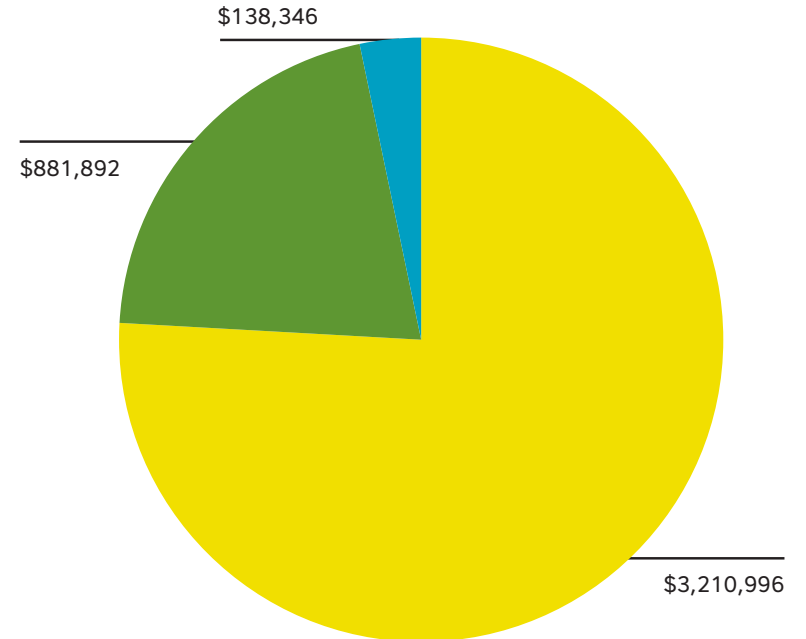

## Revenue | \$4,308,889



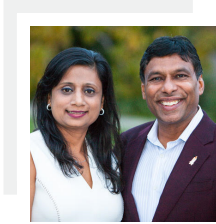
## Operating Expenses | \$4,231,234

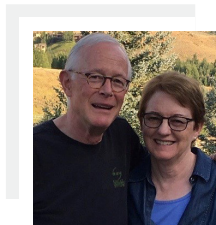

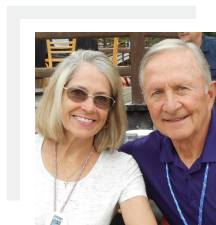
